Americans are accustomed to anecdotal evidence of the health care crisis yet personal or local stories do not provide a comprehensive nationwide picture of our access to health care now this book offers the long awaited health equivalent of national economic indicators this useful volume defines a set of national objectives and identifies indicatorsâ measures of utilization and outcomeâ that can sense when and where problems occur in accessing specific health care services using the indicators the committee presents significant conclusions about the situation today examining the relationships between access to care and factors such as income race ethnic origin and location the committee offers recommendations to federal state and local agencies for improving data collection and monitoring this highly readable and well organized volume will be essential for policymakers public health officials insurance companies hospitals physicians and nurses and interested individuals

As our nation enters a new era of medical science that offers the real prospect of personalized health care we will be confronted by an increasingly complex array of health care options and decisions the learning healthcare system considers how health care is structured to develop and to apply evidence from health profession training and infrastructure development to advances in research methodology patient engagement payment schemes and measurement and highlights opportunities for the creation of a sustainable learning health care system that gets the right care to people when they need it and then captures the results for improvement this book will be of primary interest to hospital and insurance industry administrators health care providers those who train and educate health workers researchers and policymakers the learning healthcare system is the first in a series that will focus on issues important to improving the development and application of evidence in health care decision making the roundtable on evidence based medicine serves as a neutral venue for cooperative work among key stakeholders on several dimensions to help transform the availability and use of the best evidence for the collaborative health care choices of each patient and provider to drive the process of discovery as a natural outgrowth of patient care and ultimately to ensure innovation quality safety and value in health care

The anthrax incidents following the 9/11 terrorist attacks put the spotlight on the nation's public health agencies placing it under an unprecedented scrutiny that added new dimensions to the complex issues considered in this report the future of the public's health in the 21st century reaffirms the vision of healthy people 2010 and outlines a systems approach to assuring the nation's health in practice research and policy this approach focuses on joining the unique resources and perspectives of diverse sectors and entities and challenges these groups to work in a concerted strategic way to promote and protect the public's health focusing on diverse partnerships as the framework for public health the book discusses the need for a shift from an individual to a population based approach in practice research policy and community engagement the status of the governmental public health infrastructure and what needs to be improved including its interface with the health care delivery system the roles nongovernment actors such as academia business local communities and the media can play in creating a healthy nation providing an accessible analysis this book will be important to public health policy makers and practitioners business and community leaders health advocates educators and journalists

The Institute of Medicine study crossing the quality chasm 2001 recommended that an interdisciplinary summit be held to further reform of health professions education in order to enhance quality and patient safety health professions education a bridge to quality is the follow up to that summit held in June 2002 where 150 participants across disciplines and occupations developed ideas about how to integrate a core set of competencies into health professions education these core competencies include patient centered care interdisciplinary teams

evidence based practice quality improvement and informatics this book recommends a mix of approaches to health education improvement including those related to oversight processes the training environment research public reporting and leadership educators administrators and health professionals can use this book to help achieve an approach to education that better prepares clinicians to meet both the needs of patients and the requirements of a changing health care system

the united states has the highest per capita spending on health care of any industrialized nation but continually lags behind other nations in health care outcomes including life expectancy and infant mortality national health expenditures are projected to exceed 2.5 trillion in 2009 given healthcare's direct impact on the economy there is a critical need to control health care spending according to the health imperative lowering costs and improving outcomes the costs of health care have strained the federal budget and negatively affected state governments the private sector and individuals healthcare expenditures have restricted the ability of state and local governments to fund other priorities and have contributed to slowing growth in wages and jobs in the private sector moreover the number of uninsured has risen from 45.7 million in 2007 to 46.3 million in 2008 the health imperative lowering costs and improving outcomes identifies a number of factors driving expenditure growth including scientific uncertainty perverse economic and practice incentives system fragmentation lack of patient involvement and under investment in population health experts discussed key levers for catalyzing transformation of the delivery system a few included streamlined health insurance regulation administrative simplification and clarification and quality and consistency in treatment the book is an excellent guide for policymakers at all levels of government as well as private sector healthcare workers

that began to apply the new concepts and make patient safety a reality most of these stories have not been previously told so this account becomes their histories as well iii getting to work provides in depth analyses of four key issues that cut across disciplinary lines impacting patient safety which required special attention iv creating a culture of safety looks to the future marshalling the best thinking about what it will take to achieve the safe care we all deserve captivatingly written with an insider's tone and a major contribution to the clinical literature this title will be of immense value to health care professionals to students in a range of academic disciplines to medical trainees to health administrators to policymakers and even to lay readers with an interest in patient safety and in the critical quest to create safe care
